Global Engineering & Construction Group

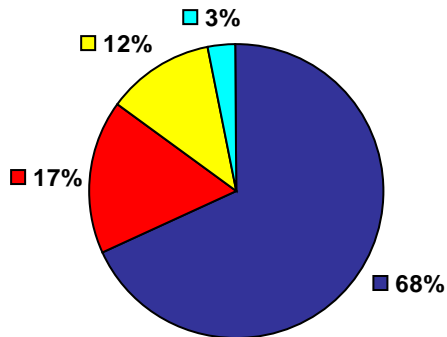
Our E&C Group accounted for about 66% of the company's scope revenues in 2009. It offers a full range of services, including studies, front-end design (FEED); engineering, procurement, construction (EPC); and project management services for the following key markets:

- Upstream oil and gas
- Midstream, including LNG liquefaction, gas-to-liquids, coal-to-gas, coal-to-liquids, carbon capture/sequestration
- Oil refining (including delayed coking)
- Chemicals and petrochemicals
- Pharmaceuticals, biotechnology and healthcare

Our E&C Group is also involved in power project development and environmental remediation.

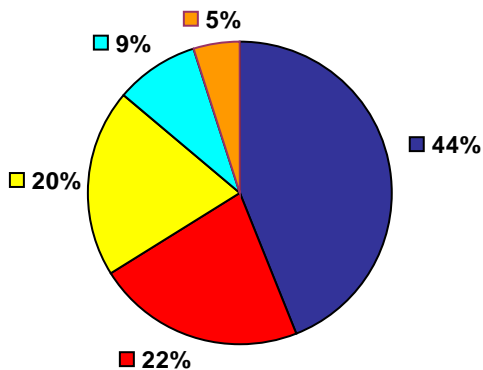

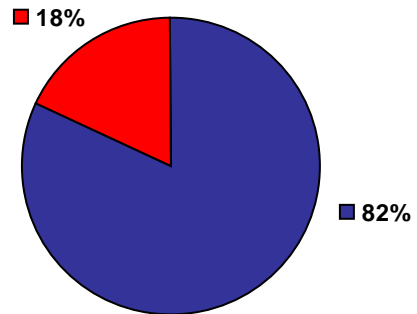
- Flexible-fuel circulating fluidized-bed (CFB) steam generators

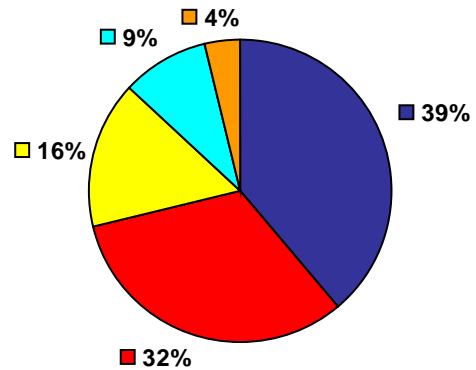
